## Councillors' update

**Shopping Trolleys** With the management of the Cowley Road Tesco changing frequently, we keep having to re-visit the issue of abandoned shopping trolleys. The local Council Committee, the East Area Parliament (EAP), met with the new manager in February and asked him to look at a more lasting solution. Apparently, several hundred costly trolleys go missing each year – so he seems keen to do something. We further encouraged him by making clear that the local Councillors would seek to use new enforcement powers if the situation did not improve. These powers mean that we could now fine Tesco for not collecting their trolleys. The number to call to report abandoned trolleys is 0845 6779520 or you can report them to staff in the store.

**Rats** Several residents reported seeing rats in Manzil Way Park – most likely attracted by the mountains of bread which someone is dumping on a regular basis. We urgently instructed officers to investigate the bread and address the rats, and are pleased to say that there is progress on both fronts. ### **Divinity Road Co-op**

We are aware of problems with loading and bin storage at the new Co-op at the lower end of Divinity Road causing an obstruction. Planning officers are currently investigating.

### **School crossing on Iffley Road**

Those who have kids at SS Mary & John School will be pleased to know that the campaign for a new crossing on Iffley Road seems to finally be making some headway. At the moment there is no safe, direct route between the two SS Mary & John sites, and residents and Councillors have long argued that the County should have put in a new crossing on Iffley Road when the school was made a split-site.

The EAP invited the County Councillor with responsibility for crossings, Cllr David Robertson, to a meeting in February to again put the case for a new crossing. We offered him some cash from our meagre local area funds to pay towards the crossing, and this seems to have had some impact.

### **New recycling scheme**

The controversial new 'wheelie bin' recycling scheme is currently being rolled out across the City, and the East Area will soon be entirely covered. In the recent City budget setting we succeeded in getting an extra £100,000 of funding to ease the introduction of the scheme but – though recognising that there are some serious teething problems – we support it as the best means of raising Oxford's dismal recycling rate.

Collections alternate: one week the green wheelie bin and green box are emptied and the next week the blue box and garden waste sack are emptied. A calendar has gone to each household to provide a reminder of what gets collected when and, if you have a mobile, you can text your collection day (e.g. Wednesday) to 07786 200424 and you will be sent a text reminder. You can also register for email reminders. If you want a small wheelie bin, or sack, instead of a big wheelie bin then phone 252900. If you are a champion recycler and want a blue wheelie bin, instead of a box, then call the same number. Do contact us if problems persist.

## **Oxford Brookes licensing application**

Oxford Brookes Student Union has submitted a variation to its Club Premises Certificate (Ref.

07/00158/CLUB). It wants to extend the hours for supplying alcohol on Wednesday nights until 3 am on the following day, and on Friday and Saturday nights until 4 am on the following day. The Union has also submitted a variation to its premises licence (Reference: 07/00156/PREM) to include existing and additional types of regulated entertainment: Mondays till 2.30 am on the following day; Sundays, Tuesdays and Thursdays till 12.30 am; Wednesdays till 3.30 am and Fridays and Saturdays till 4.30 am; and to extend the number of events from 24 to 36 a year. **DRARA and many residents on their own account**, have objected to these proposals. A public hearing will take place on 3 April in the Town Hall at 9.30 am. All welcome.

## **Old Bingo Hall licensing application**

An appeal by Solarview Ltd. against the refusal of the City Council Licensing Committee to grant a licence for recorded music, dancing, and selling alcohol was heard by magistrates on 16 March. Magistrates accepted the appeal, subject to certain conditions. The venue will now be able to open after midnight on Thurs (til 2am the following day), Fri (til 3am), and Sat (til 4am). A comprehensive travel plan is also required, but with capacity of up to 1750, no parking and no taxi rank, residents can expect some disruption.

There is another application pending for the Bingo Hall for reduced hours (noon-midnight 3 days and noon-2am the other four days), but it is up to the applicant if he still wish to proceed with this. ## Warneford Hospital Playing Field, Park Hospital and Warneford Meadow

DRARA has joined with Friends Of Warneford Meadow and other Residents' Associations in a joint campaign to oppose the planning applications made by The Oxford Mental Healthcare Trust in respect of these sites. The main grounds of objection are: the additional traffic that these developments would bring to local streets (particularly with the massive new developments at the Churchill Hospital site); the increased pressure on parking space in Hill Top Road, and at the top of Divinity Road and Southfield Road; the change in the character of the local area that would result from large-scale development of these sites; and the loss of the amenity of Warneford Meadow that would result from losing half of it to development.

The Local Plan provides that planning permission will be granted for various uses at these three sites. At the time that it was drawn up, the need of the Mental Healthcare Trust to build a new hospital, and the need of Brookes University for additional academic floorspace and student accommodation, were the drivers behind the allocation of Warneford Hospital and Warneford Meadow as development sites.

However, circumstances have changed since then. The Mental Healthcare Trust has applied for a use other than the one provided for in the Local Plan for the Hospital Playing Field site. Brookes University has not expressed an interest in these sites for additional academic floorspace, and several brownfield sites have been granted permission for student accommodation since the Local Plan was drawn up, which means that there can no longer be justification for the loss of a greenfield site to **these forms** of development.

These arguments were put forward by local groups, including DRARA, at the meeting of the Council's North-East Area Committee in January. The Committee recommended that development should take place at the Park Hospital and Warneford Playing Field sites, but that none should take place at Warneford Meadow. These recommendations will now go to the Council's Planning Committee, probably on **April 25**, which will decide on these applications.

## Friends of Warneford Meadow (FOWM)

Through public meetings, local press campaigns and a travelling exhibition the Friends Of Warneford Meadow campaign group has in recent months captured the imagination of people in East Oxford and Headington. A major success came when all the neighbouring residents associations agreed to campaign against any development on the Meadow. The joint front presented at the North East Area

Committee (NEAC) meeting in January was undoubtedly a major factor in the councillors decision. Another factor was the 250 letters of objections which were written to Oxford City planners and we also hope to present a petition to the Lord Mayor before the plans are discussed.

Parallel to this planning process is the Town Green proposal submitted by local resident Paul Deluce in December. This application has now been accepted by the County Council and now starts an anticipated 4-6 month process before this is resolved. FOWM doubt if this will halt the planning process but unless the proposal is rejected it is likely to affect the market price of the Meadow.
